## WHAT THE HECK WENT ON IN KANSAS?

There is a big problem with an aspect of Kansas voter registration in 2020, and it highlights a big national problem that stems from (as many problems do) the HAVA act ("the HELP AMERICA VOTE DEMOCRAT ACT").

One of the oft-overlooked aspects of this act was the establishment of HAVV identity checks, which is run by the Social Security Administration. 39 states are signed up to use HAVV, and 38 of them were actively using it in 2020.

It goes a little something like this. Charlie decided he wanted to register to vote in 2020. So, Charlie trundles down to his nearest election office and announces his intentions. But there is a problem. Charlie has either forgotten his driver's license, passport, or other state issued ID, or he was too lazy or intellectually challenged to obtain a free ID card from his state. What is poor Charlie to do? Have the racist Republicans managed to disenfranchise yet another voter? Will the election office tell him to simply carry on, wayward son?

HAVV to the rescue! By supplying his name, birthdate, and last 4 digits of his social security number, he can still be registered if the clerk

enters this information into the HAVV website and it returns a match. Charlie gets his voter ID and goes back home secure in the notion that he is going to participate in our "Democracy".

For reference, the HAVV system can respond to a check in the following ways:

- 1. Match (good to go)
- 2. No Match (something's wrong)
- 3. Match Deceased (something's *really* wrong)
- 4. Match Multiple (should be extremely rare)

That's how it is *supposed* to work. (Maybe)

In the real world, some offices don't have access to HAVV (or even the internet). So, they take the info, thank Charlie, and give him the voter ID. His info is sent somewhere else to be checked at a later date along with all the others who took the time to go to the election office but forgot their driver's license. (If anyone brings up my recent adventure at the airport, there will be trouble). Some do, but the clerk receives so many rejections (more on this below) that they figure the system is broken and register the voter anyway. After all, Charlie has an honest face.

Based upon discussions with numerous people involved with elections, these checks are performed but the results largely ignored. This is a real problem and I believe that this is one of the methods used to pad voter rolls. My raccoon sense also tells me that we will eventually find a link to the ERIC registration system if we keep digging hard enough.

A reasonable person would think that the need for HAVV checks would be minimal. Most people have appropriate ID, after all, and most of them aren't dumb enough to go somewhere important without it. (Shut up all of you snickering in the back. I thought I had my ID when I left for the airport, honest.)

But why have I decided to pick on poor Kansas?

Because Kansas had the worst abuse of HAVV in the *country*. Let me give you the numbers, which are taken from the SSA's HAVA website.

In the first third of 2020, 1,823 HAVV checks were performed across the state. 399 were rejected, with 199 of then coming back as "deceased". Then, starting in May, something nefarious started happening. The SSA reports these statistics by week, and the week ending May 2<sup>nd</sup>, 3,113 checks were made. Of those, 743 were returned as "no match", and 741 were returned "match deceased".

Read that again.

This was a harbinger of things to come.

Look at the number of HAVV checks, the number of "no matches", and the number or "matched deceased" for the weeks up until the November Election. I am intentionally making a page break to give you time to cinch up your socks.

Yes. You see the numbers. You can't "un-see" them. Someone was making a big move to inflate the Kansas voter rolls and however they were doing it, HAVV checks were being involved.

Stated a different way, during this period, here are over 56,000 examples of attempted identity theft by using a dead person's information. I am certain that the authorities in Kansas investigated and prosecuted every single one of them. Stop laughing.

Remarkably, this same phenomenon continued after the election. Between the election and June 19<sup>th</sup>, 2021, an additional 1,330,639 HAVA checks were made, with 357,578 not matching and 119,919 matching deceased persons. Then, starting the week of June 26<sup>th</sup>... it basically stopped. Like some huge finger had pressed some huge offbutton. The checks from that point on averaged 111 a week after that.

I want to point out now for the record that I know that others have reported on problems with these HAVV checks. (I myself wrote some web pages to view the data back in September). However, just reporting some strange numbers isn't ever going to fix our problems. Like many other issues, including the crazy Edison reporting numbers, Maidengate, etc, the tendency by many researchers has been to identify something, report on it, then move on without the deep analysis needed to explain the "why" and "how" of the anomaly, and if very lucky, the "who". We need to take every meaty piece of data we have and chew on it until half the bone is gone. Until it crumbles to the ground.

Serious questions need to be asked of the state of Kansas Election officials, and there must be demands to demystify the registration process as a whole in every state. While other states also show evidence that the HAVV system is being used for roll padding purposes, no state has nearly the number of deceased matches as Kansas. (Interestingly, Arizona is the only state with a higher number of overall HAVV failures).


