INTRODUCTION

This document has been prepared from my examination of the UserLog table of the Antrim Dominion database. There have been other analyses of this system, but I believe this shows that the problems being encountered by Antrim County in the November 2020 election were even more pervasive than originally thought.

My opinion based upon this information is that either the personnel at the Antrim County election office are among the most incompetent in the country, or they were fighting against something which was attempting to interfere with their systems.

ODD LOG ENTRIES

Two times, on 10/5/2020 and 10/13/2020, there is an item that says "**Project Wayne County 2020 November Election Closed**"? With no corresponding items that say it was opened? Why was the Antrim machine even dealing with the Wayne County Election?

LAST MINUTE CHANGES

Total Number of Eligible voters for precincts edited on Nov 2 and 3 (up to 6pm on the 3rd still doing it). Might be a normal thing to do but just in case, noting it. However, the following precincts have "0" eligible voters in the database:

BATCH NAMING CONVENTION INFORMATION

Each batch comes in and is assigned a unique "filename". This document is using that filename to refer to an individual batch. In the system, the batch id listed here is followed by either DETAIL (if created automatically) or MANUAL (if the record had to be created manually).

SEQUENCE OF EVENTS IN ANTRIM

DAY ONE - NOVEMBER 3rd – 4th, 2020

Batch 1120_3_3_0 was successfully processed at 9:49 PM. It was 197-3 for Biden.

Between 10:31 PM and 10:38 PM, batch 1120_16_16_0 was tried 7 times, failed each time.

1120_1_1_0 and 1120_5_5_0 subsequently loaded successfully. They had votes 756-349 for Trump and 392-8 for Biden, respectively.

At 10:56 PM, 1120 16 16 0 failed again for the 8th time.

Between 11:05 PM and 12:18 AM on the 4th, Warner Township's contest setup was updated. Batch 1120_16_16_1000 was successfully processed at 12:18 AM. It had 163-60 for Trump.

1120_8_8_0 (432-4 for Biden) and 1120_14_!4_0 (462-10 for Biden) were then loaded successfully.

At 12:28 AM, an error appeared "Result file 1120_6_6_0_DETAIL_DVD has not been closed. Result file will be loaded." This is odd because that batch had not been referenced before. This was quickly followed by the error "The database already contains results for tabulator Elk Rapids Township, Precinct 1 ICP for batch 0" (at 12:33 AM). And the exact same error again the next minute.

The clerk might have pounded the keyboard in frustration or something because at 12:31 AM the message popped up "Do you want to leave Tally and Reporting". They answered "No". I suspect they ended up regretting that decision.

Batch 1120_6_100_0 was processed successfully (414-4 for Biden), followed by two more of the same "Elk Rapids" errors referenced above at 12:33 AM.

Batches 1120_15_15_0, 1120_7_7_0 (755-19 for Biden), and 1120_13_110_0 (43-6 for Biden) were then processed successfully.

At 12:39 AM two more "database already contains results" errors came up, this time for Milton Township, Precinct 1 ICP.

At 1:54AM the database shows a load of batch 1120_6_6_1000, with votes 784-611 for Biden. This load does not appear to be in the log files.

There is now a pause while Election Reports are run. Surely they should have noticed that the Biden numbers were impossible. But they apparently did not as they continued on.

Between 1:01 AM and 1:42 AM, Elk Rapids Township's contest setup was updated. Batch 1120_2_2_0 was successfully processed at 1:43 AM. (908-549 for Trump)

Between 1:48 AM and 2:04 AM, Milton Township's contest setup was updated. Batch 1120_13_13_1000 was successfully processed at 2:04 AM. (478-143 for Trump)

There then was another pause while the "Election Summary Report" was run twice, and the "Statement of Votes Cast" was run 3 times. From this point on they began running these between every batch they processed. However, no steps were apparently taken indicating that they realized that the numbers were WAY off.

Batch 1120_9_9_0 was processed successfully at 2:31 AM (372-13 for Biden), then they took an hour break. Or a nap.

Batches 1120_10_10_0, 1120_11_11_0,(835-276 for Trump) and 1120_11_12_0 (646-247 for Trump) were processed successfully in quick succession between 3:43 AM and 3:49 AM.

After running some more reports, they decided to create a custom report although I cannot tell the nature of it. It was evidently at this point that they published the vote counts, which showed Biden with a several thousand vote lead.

DAY TWO – NOVEMBER 4th, 2020

At 9:05 AM the Results Tally Module was opened. There was then a long period of inactivity now, until 2:30 PM. I suspect they had been informed how bad their numbers were and were figuring out what to do.

At 2:30 PM, someone changed the status of the 1120 2 2 0 batch to "rejected".

At 3:20 PM, someone changed the status of the 1120_3_3_0 batch to "rejected".

The database shows another load of 1120_2_2_0 batch at 3:24, not there is no record of it in the log files. How this got loaded is a mystery, but it shows 908-549 for Trump, the same numbers from the early morning load. At some point it was also marked as "rejected".

Between 3:24 PM and 4:04 AM, Chestonia Township's contest setup was updated. Batch 1120_3_3_1000 was successfully processed for the second time at 4:04 PM, this time showing 197-93 for Trump (90 more votes counted than the last time, and 194 slipped to Trump).

Between 4:05 PM and 4:50 PM, Custer Township's contest setup was updated. Batch 1120_4_4_1000 was successfully processed at 4:50 PM, this time showing 521-240 for Trump (over 230 votes more than the first load).

Between 4:54 PM and 5:20 PM, Echo Township's contest setup was updated. Batch 1120_5_5_1000 was successfully processed again at 5:20 PM, this time 392-198 Trump, adding 200 new votes.

Between 5:36 PM and 5:57 PM, Elk Rapids Township's contest setup was updated. Batch 1120_6_100_1000 was successfully processed at 5:57 PM, this time showing 414-202 for Trump, adding almost 200 more votes.

At 5:58 PM, batch 1120_7_7_0 was marked as rejected.

Between 6:04 PM and 6:33 PM, Forest Home Township's contest setup was updated. Batch 1120_7_7_1000 was successfully processed at 6:33 PM showing 753-610 for Trump and adding about 600 votes.

DAY THREE - NOVEMBER 5th, 2020

At 7:45 AM, batch 1120 8 8 0 was marked as rejected.

Between 7:47 AM and 8:00 AM, Helena Township's contest setup was updated. Batch 1120_8_8_1000 was successfully processed at 8:01 AM, showing 431-306 for Trump.

At 8:21 AM, batch 1200 9 9 0 was marked as rejected

Between 8:21 AM and 8:58 AM, Jordan Township's contest setup was updated.

Batch 1120_9_9_1000 was successfully processed at 9:06 AM, showing 371-183 for Trump and adding about 150 votes.

At 9:07 AM batch 1120_10_10_0 was marked as rejected.

Between 9:07 AM and 10:16 AM, Kearney Township's contest setup was updated. It seems they had a few more problems with this setup than the others.

Batch 1120_10_10_1000 was successfully processed at 10:16 AM, showing 743-471 for Trump, and adding about 500 votes.

The Antrim project was closed at 10:20 AM and immediately re-opened.

At 10:22 AM, the CF card for tabulator Central Lake Township, Precinct 1 ICP was programmed, tabulator files copied, and a backup made. This process took until 10:23 AM.

At 11:33 AM, batch 1120 13 110 0 was marked as rejected.

From 11:34 AM to 11:48 AM, Milton Township's contest settings were once again updated. Batch 1120_13_110_1000 was successfully processed at 11:48 AM, showing 626-543 for Biden, adding about 600 votes.

At 11:54 AM, batch 1120 14 14 0 was set to rejected.

Between 11:56 AM and 12:06 PM, Star Township's contest setup was updated.

Batch 1120_14_14_1000 was successfully processed at 12:06 PM, showing 462-161 for Trump and adding about 150 votes.

At 12:26 PM, batch 1120_15_15_0 was marked as rejected.

From 12:26 PM to 1:13 PM, Torch Lake Township's contest setup was updated Batch 1120_15_15_1000 was successfully processed at 1:13 PM, showing 526-462 for Trump adding about 450 votes.

Between 3:40 PM and 4:41 PM, Central Lake Township had its contest setup updated. Batch 1120_2_2_1000 was successfully processed at 4:41 PM. **This load does NOT show up in the database.**

The Antrim project was closed at 5:54 PM.

DAY FOUR - NOVEMBER 6th, 2020

Only activity between 7:49 AM and 9:16 PM was report generation.

At 9:16 PM, batch 1120_2_2_1000 was marked as rejected (again).

From 9:17 PM to 9:49 PM, Central Lake Township's contest setup was updated (again) Batch 1120_2_2_1001 was successfully processed at 9:49 PM. This was the third load for this batch, and this time is had 906-549 for Trump (taking away 2 Trump votes from the previous time).

The Antrim project was closed at 10:38 PM.

DAY THIRTEEN – NOVEMBER 16th, 2020

At 1:16 PM, batch 1120_10_10_1000 was marked as rejected. Again.

Between 1:37 PM and 2:52 PM, Kearney Township's contest setup was again updated. Batch 1120_10_10_1001 was successfully published at 2:58 PM. This was the third load for this batch, and this time it shows 743-471 Trump, the same as the previous load.

DAY SEVENTEEN – NOVEMBER 20th, 2020

Project opened at 4:37 PM.

At 6:06 PM, batch 1120_3_3_1000 was marked as "Rejected".

Between 6:09 PM and 6:44 PM, Chestonia Township's contest setup was updated. Again. Batch 1120_3_3_1001 was successfully processed at 6:44 PM. This was the third go-around for this batch, and it shows 197-93 for Trump, the same as the previous load.

Results Tally and Reporting exited at 6:48 PM.

DAY EIGHTEEN - NOVEMBER 21st, 2020 THE LAST DAY

At 9:13 AM, batch 1120_8_8_1000 was marked as rejected.

Between 9:14 AM and 9:36 AM, Helena Township's contest setup was updated. Again. Batch 1120_8_8_1001 was successfully processed (for the third time) at 9:42 AM, and produced the same 431-306 votes for Trump as the last time.

All activity involved report creation until 11:22 AM.

At 11:22 AM, batch 1120_13_110_1000 was marked as rejected.

Between 11:22 AM and 11:36 AM, Milton Township's contest setup was updated. Again. Batch 1120_13_11_1001 was successfully processed for the third time at 11:36 AM, and produced the same 626-543 for Biden as the previous load.

At 11:47 AM, batch 1120 14 14 1000 was marked as rejected.

Between 11:47 AM and 12:00 PM, Star Township's contest setup was updated. Again. Batch 1120_14_14_1001 was successfully processed at 12:01 AM. Same 462-161 for Trump as the last load.

At 12:03 PM, batch 1120 6 6 1000 was marked as rejected.

Between 12:05 PM and 12:38 PM, Elk Rapids Township's contest setup was updated. Again. Batch 1120_6_6_1002 was successfully processed at 12:39 PM. It produced a tie – 288 votes for Trump and Biden.

At 12:42 PM, batch 1120_6_6_1000 was marked as rejected. Again. Once more unto the breach. Between 12:42 PM and 1:20 PM, Elk Rapids Township's contest setup was updated. Again. Batch 1120_6_6_1001 was successfully processed at 1:10 PM. This time it showed 784-611 for Biden as it had the first load (but not the second).

The database shows a reload of batch 1120_6_100_1001, with votes 414-202 for Trump. This is the same votes as in the previous load, but record of this was not found in the logs.

At 1:19 PM, batch 1120_4_4_1000 was marked as rejected. Again.

Between 1:20 PM and 2:11 PM, Custer Township's contest setup was updated. Again. Batch 1120_4_4_1001 was successfully processed at 2:12 PM, with the same 521-240 for Trump as the last load.
